# **MEDICINAL PLANTS, PHYTOTHERAPY AND AROMATHERAPY**

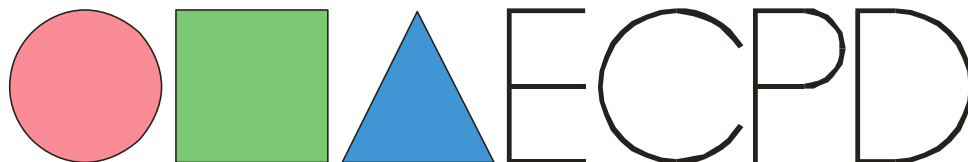
**(Vrnjačka Banja, 09 - 10 December 2016)**

organised in cooperation with the ECPD International Educational Base, Company „Ljbilje“ Ljubinje.

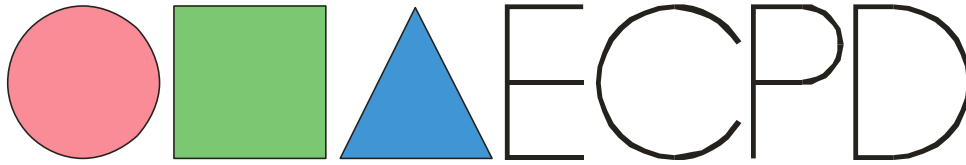

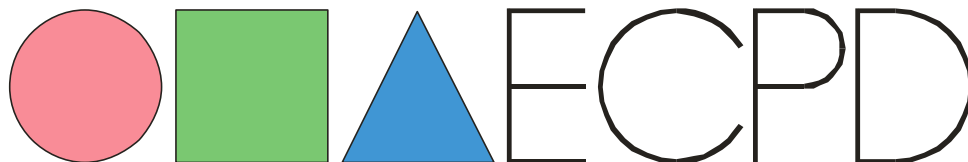
